Message from the CEO

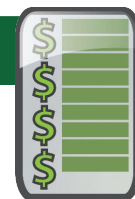
Happy Spring! Wow what a winter! Thanks for all your patience during our water line issue in February! Our great employees really did a wonderful job serving the membership during this difficult time.
